

*APPLICATION FOR PERMIT

To appropriate the Public Waters of the State of Oregon

I, W. S. MacGregor (Name of applicant) of P. O. Box 248, Applegate, (Mailing address) State of Oregon 97530, do hereby make application for a permit to appropriate the

following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Thompson Creek (Name of stream), a tributary of Applegate River.

2. The amount of water which the applicant intends to apply to beneficial use is 0.09 c.f.s. cubic feet per second. (If water is to be used from more than one source, give quantity from each)

**3. The use to which the water is to be applied is irrigation. (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located 990 ft. N. and 540 ft. E. from the SW corner of Section 22 (Section or subdivision)

being within the SW 1/4 SW 1/4 of Sec. 22, Tp. 38 S., R. 4 W., W. M., in the county of Jackson. (Give smallest legal subdivision) (N. or S.)

5. The pipe line to be 2000 feet (Main ditch, canal or pipe line) (Miles or feet) in length, terminating in the NE 1/4 SE 1/4 of Sec. 21, Tp. 38 S., R. 4 W., W. M., the proposed location being shown throughout on the accompanying map. (Smallest legal subdivision) (N. or S.)

DESCRIPTION OF WORKS

Diversion Works—

6. (a) Height of dam feet, length on top feet, length at bottom feet; material to be used and character of construction to pump from a small hole excavated in stream bed. (Loose rock, concrete, masonry, rock and brush, timber crib, etc., wasteway over or around dam)

**Application for permits to appropriate water for the generation of electricity, with the exception of municipalities, must be made to the Hydroelectric Commission. Either of the above forms may be secured, without cost, together with instructions by addressing the State Engineer, Salem, Oregon.

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.09 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from Thompson Creek

The use to which this water is to be applied is irrigation

If for irrigation, this appropriation shall be limited to 1/80 of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year.

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is December 24, 1969

Actual construction work shall begin on or before August 11, 1971 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1972...

Complete application of the water to the proposed use shall be made on or before October 1, 1973...
