To appropriate the Public Waters of the State of Oregon

I, PAUL E. AND MARY LEE JONES (Name of applicant) of Box 23, GARDINER, (Mailing address) State of OREGON, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Spring (Name of stream), a tributary of NORTH FORK SIUSLAH RIVER

2. The amount of water which the applicant intends to apply to beneficial use is 0.01 cubic feet per second. (If water is to be used from more than one source, give quantity from each)

\*\*3. The use to which the water is to be applied is DOMESTIC USE FOR 1 FAMILY, (Irrigation, power, mining, manufacturing, domestic supplies, etc.) INCLUDING IRRIGATION NOT TO EXCEED 1/2 ACRE LAWN AND GARDEN

4. The point of diversion is located 10 ft. N and 1.68 ft. E from the SW Sec. corner of SECTION 13, T.17S, R.11W. (Section or subdivision)

being within the SW 1/4 SW 1/4 (Give smallest legal subdivision) of Sec. 13, Tp. 17S, R. 11W, W. M., in the county of LANE

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.01 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from a spring

The use to which this water is to be applied is domestic use for one family including the irrigation of lawn and garden not to exceed 1/2 acre in area.

If for irrigation, this appropriation shall be limited to of one cubic foot per second or its equivalent for each acre irrigated

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is June 1, 1970

Actual construction work shall begin on or before May 26, 1972 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1973.

Complete application of the water to the proposed use shall be made on or before October 1, 1974. Extended to Oct. 1 1974.
