

*APPLICATION FOR PERMIT

To appropriate the Public Waters of the State of Oregon

I, Lonella E. Kerber (Name of applicant) of Rta Bx94 Monmouth (Mailing address), State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Pitnet Creek (Name of stream), a tributary of Luckiamute River

2. The amount of water which the applicant intends to apply to beneficial use is 0.735 cubic feet per second. Div Pt #2 - 0.388 cfs - Div Pt #3 0.346 cfs (If water is to be used from more than one source, give quantity from each)

**3. The use to which the water is to be applied is Irrigation (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located 320 ft. W. and 6 ft. N. from the Sec. corner of Common to Secs 5, 6 (31, 32) T. 9, 10 S. R. 6 W. (Section or subdivision)

Div. Pt. #4 is located 450 ft. E. and 770 ft. S from the Sec. Corner Common to Secs 5, 6 T. 10 S. R. 6 W. within NW 1/4 NW 1/4 Sec. 5 (If preferable, give distance and bearing to section corner)

being within the #2 SW/NW Sec 5 #3 SE/SE Sec 3 of Sec. 5-105 (Give smallest legal subdivision) (N. or S.)

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.735 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from Ritner Creek

The use to which this water is to be applied is irrigation

If for irrigation, this appropriation shall be limited to 1/80 of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year.

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is June 30, 1970

Actual construction work shall begin on or before May 26, 1972 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1973.

Complete application of the water to the proposed use shall be made on or before October 1, 1974.
