# To Appropriate the Public Waters of the State of Oregon

I, Royel Allen (Name of applicant)

of John Day (Mailing address)

State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, **SUBJECT TO EXISTING RIGHTS:**

If the applicant is a corporation, give date and place of incorporation

1000 feet above residence, a tributary of Canyon Creek (in wet weather)

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.002 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from a spring

The use to which this water is to be applied is domestic use for two families

If for irrigation, this appropriation shall be limited to of one cubic foot per second or its equivalent for each acre irrigated

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is August 3, 1970

Actual construction work shall begin on or before November 23, 1972 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1973

Complete application of the water to the proposed use shall be made on or before October 1, 1974.
