Beginning at a point 761.0 feet South of the Northwest corner of the Northeast quarter (NE $\frac{1}{4}$) of the Southeast quarter (SE $\frac{1}{4}$) of Section Seven (7), Township twenty-seven (27) South, Range Eleven (11) West of the Willamette Meridian in Coos County, Oregon; said point being at the intersection of the quarter quarter ($\frac{1}{16}$) line with the North line of the Coos Bay Lumber Co. railroad right of way; then South 61 47' West along said North right of way line 399.16 feet to the junction with the East line of the County Road; thence North 13 23' East along said County Road 440.01 feet; thence South 76 37' East 252.98 feet to the Quarter quarter ($\frac{1}{4}$) line; thence South 179.87 feet to the point of beginning.

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.01 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from North Fork Coquille River

The use to which this water is to be applied is irrigation

If for irrigation, this appropriation shall be limited to 1/80 of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year.

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is April 6, 1971

Actual construction work shall begin on or before November 27, 1973 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1974.

Complete application of the water to the proposed use shall be made on or before October 1, 1975.
