The right herein granted is limited to the amount of water which can be applied to beneficial use  
and shall not exceed 6.5 acre feet stored water only measured at the point of diversion from the  
stream, or its equivalent in case of rotation with other water users, from Fischer Reservoir #1 to  
be constructed under application No. R-48750, permit No. R-5913

second or its equivalent for each acre irrigated .....


and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.
