To Appropriate the Public Waters of the State of Oregon

I, Elden C. Snyder (Name of applicant)

State of Oregon, 97526, do hereby make application for a permit to appropriate the (Zip Code)

following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

1. The source of the proposed appropriation is Ferris Gulch, (Name of stream)

, a tributary of Applegate River.

2. The amount of water which the applicant intends to apply to beneficial use is 0.26 c.f.s. cubic feet per second (If water is to be used from more than one source, give quantity from each)

3. The use to which the water is to be applied is supplemental irrigation. (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located 530 ft. N. and 250 ft. E. from the SW corner of Section 17 (N. or S.) (E. or W.) (Section or subdivision)

DESCRIPTION OF WORKS

Diversion Works—

6. (a) Height of dam 3.0 feet, length on top 15 feet, length at bottom 10 feet; material to be used and character of construction loose rock and dirt. to facilitate pumping only. (Loose rock, concrete, masonry, rock and brush, timber crib, etc., wasteway over or around dam)

(b) Description of headgate (Timber, concrete, etc., number and size of openings)

(c) If water is to be pumped give general description 2" centrifugal pump powered by a 10 H.P. electric motor. (Size and type of pump) (Size and type of engine or motor to be used, total head water is to be lifted, etc.)

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.26 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from Ferris Gulch

The use to which this water is to be applied is supplemental irrigation

If for irrigation, this appropriation shall be limited to 1/80 of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply for any prior right existing for the same land and shall not exceed the limitation allowed herein,

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is May 5, 1972

Actual construction work shall begin on or before July 27, 1974 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1975...

Complete application of the water to the proposed use shall be made on or before October 1, 1976...
