# To appropriate the Public Waters of the State of Oregon

State of OREGON, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

### DESCRIPTION OF WORKS

#### Diversion Works—

6. (a) Height of dam 2 feet, length on top 5 feet, length at bottom 3 feet; material to be used and character of construction wood batten with earth face wasteway over dam  
(Loose rock, concrete, masonry, rock and brush, timber crib, etc., wasteway over or around dam)  
(b) Description of headgate TIMBER 1 12" x 4"  
(Timber, concrete, etc., number and size of openings)

(c) If water is to be pumped give general description 1/2 hp shallow well jet pump

1" inlet and 1" outlet to be used for pressure from holding tank 55' from house water to come from dam to holding tank by gravity system. (See item #7)

\*\*Application for permits to appropriate water for the generation of electricity, with the exception of municipalities, must be made to the Hydroelectric Commission. This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.005 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from unnamed creek

The use to which this water is to be applied is domestic use for 1 family

If for irrigation, this appropriation shall be limited to of one cubic foot per second or its equivalent for each acre irrigated

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is December 12, 1972

Actual construction work shall begin on or before January 13, 1976 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1976.

Complete application of the water to the proposed use shall be made on or before October 1, 1977.
