To Appropriate the Public Waters of the State of Oregon

I, Elmer R. Davis (Father) Mary Lu Davis Johnson (Daughter) of Route 3, Walla Walla, Washington (Farm in Umatilla County) State of ... do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is North Fork of Cottonwood Creek, a tributary of Walla Walla River

2. The amount of water which the applicant intends to apply to beneficial use is 0.01 (1/100) cubic feet per second

3. The use to which the water is to be applied is Domestic supplies, IRRIGATION

4. The point of diversion is located 1.516 ft. N and 2.046 ft. E from the S.W. corner of section 18

being within the NE 1/4 of SW 1/4 of Sec. 18, Tp. 6 N, R. 37 E, W. M., in the county of Umatilla

5. The Pipe to be 235 Feet in length, terminating in the NE 1/4 of SW 1/4 of Sec. 18, Tp. 6 N, R. 37 E, W. M., the proposed location being shown throughout on the accompanying map.

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.01 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from North Fork Cottonwood Creek

The use to which this water is to be applied is irrigation

If for irrigation, this appropriation shall be limited to 0.0375 of one cubic foot per second or its equivalent for each acre irrigated

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is February 9, 1973

Actual construction work shall begin on or before January 13, 1976 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1976.

Complete application of the water to the proposed use shall be made on or before October 1, 1977.
