The right herein granted is limited to the amount of water which can be applied to beneficial use stream, or its equivalent in case of rotation with other water users, from Little Applegate River The use to which this water is to be applied is \_\_\_\_\_\_irrigation\_\_\_\_\_ second or its equivalent for each acre irrigated and shall be further limited to a diversion.... of not to exceed 42 acre feet per acre for each acre irrigated during the irrigation season of each year. and shall be subject to such reasonable rotation system as may be ordered by the proper state officer. The priority date of this permit is ......April 26, 1973.... Actual construction work shall begin on or before ......August.13, 1976..... and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19.77...
