To Appropriate the Public Waters of the State of Oregon

I, Allan A. Kearney (Name of applicant)

following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

1. The source of the proposed appropriation is South Umpqua River (Name of stream), a tributary of Umpqua River

2. The amount of water which the applicant intends to apply to beneficial use is 0.02 cubic feet per second (If water is to be used from more than one source, give quantity from each)

3. The use to which the water is to be applied is irrigation (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located 1320 ft. N and 80 ft. E from the SW corner of Section 25 (Section or subdivision)

DESCRIPTION OF WORKS

Diversion Works—

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.02 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from South Umpqua River.

The use to which this water is to be applied is irrigation.

If for irrigation, this appropriation shall be limited to 1/80th of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year.

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is May 2, 1973.

Actual construction work shall begin on or before August 13, 1976 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1977.

Complete application of the water to the proposed use shall be made on or before October 1, 1978.
