\*APPLICATION FOR PERMIT

To Appropriate the Public Waters of the State of Oregon

I, Mark E. Williams (Name of applicant) of RT. 2 Box 167 (Mailing address), McMinnville (City), State of Oregon, 97128 (Zip Code), do hereby make application for a permit to appropriate the following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Hawn Creek & Hawn Creek Reservoir (Name of stream), a tributary of Yamhill River

2. The amount of water which the applicant intends to apply to beneficial use is 0.18 cubic feet per second (If water is to be used from more than one source, give quantity from each)

3. The use to which the water is to be applied is irrigation of 14.2 ac (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located 1590 ft. S and 810 ft. W from the SE corner of Hembree DLC 69 (Section or subdivision)

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed .....0.18..... cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from ....Hawm Creek and Hawm..... Creek reservoir constructed under permit No. R-2570.....

The use to which this water is to be applied is .....irrigation.....

If for irrigation, this appropriation shall be limited to .....1/80th..... of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year.....
