

The right herein granted is limited to the amount of water which can be applied to beneficial use  
and shall not exceed ..... 0.01 ..... cubic feet per second measured at the point of diversion from the  
stream, or its equivalent in case of rotation with other water users, from ..North Umpqua River.....

The use to which this water is to be applied is ..domestic use for 1 family including.....

If for irrigation, this appropriation shall be limited to ..... of one cubic foot per


