

*APPLICATION FOR PERMIT

To Appropriate the Public Waters of the State of Oregon

I, Roland R. Hanselmann CERTIFICATE NO. 46256
of Smith River Rt. Box 28 Drain
State of Oregon 97435, do hereby make application for a permit to appropriate the

following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Unnamed stream
a tributary of Smith River

2. The amount of water which the applicant intends to apply to beneficial use is 0.01
cubic feet per second

3. The use to which the water is to be applied is domestic supplies
including irrigation of lawn & garden not to exceed 1/2 acre

4. The point of diversion is located 2500 ft. N. and 300 ft. E. from the SW
corner of section 33

being within the NW 1/4 SW 1/4 of Sec. 33, Tp. 20 S,
R. 6 W., W. M., in the county of Douglas

5. The main pipe line to be 500 feet
in length, terminating in the NW 1/4 SW 1/4 of Sec. 33, Tp. 20 S,
R. 6 W., W. M., the proposed location being shown throughout on the accompanying map.

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed0.01..... cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from unnamed stream

The use to which this water is to be applied is domestic use for 1 family including the irrigation of lawn and garden not to exceed 1/2 acre in area.

If for irrigation, this appropriation shall be limited to of one cubic foot per second or its equivalent for each acre irrigated

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is June 4, 1975.....

Actual construction work shall begin on or before September 19, 1976..... and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1977..

Complete application of the water to the proposed use shall be made on or before October 1, 1978..
