To Appropriate the Public Waters of the State of Oregon

I, Olive O'Leary (Name of applicant) of Rt 1, Willamina (City), Oregon 97396 (Zip Code), do hereby make application for a permit to appropriate the

following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

1. The source of the proposed appropriation is Rowell Creek (Name of stream), a tributary of S Yamhill R

2. The amount of water which the applicant intends to apply to beneficial use is 0.03 cubic feet per second being 0.025 cfs for irrig & 0.005 cfs for domestic (If water is to be used from more than one source, give quantity from each)

3. The use to which the water is to be applied is irrigation of 1 1/4 acres & supplemental to a well for household supplies (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located 1000 ft. S and 2050 ft. W from the NE corner of Section 17 T6S R7W W.M. for irrigation (Section or subdivision)

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.03 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from Rowell Creek

The use to which this water is to be applied is for domestic use for one family and irrigation, being 0.005 c.f.s. for domestic and 0.025 c.f.s. for irrigation

If for irrigation, this appropriation shall be limited to 1/80th of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is April 29, 1975

Actual construction work shall begin on or before November 3, 1976 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1977.

Complete application of the water to the proposed use shall be made on or before October 1, 1978.
