To Appropriate the Public Waters of the State of Oregon

I, Donn A. Reising (Name of applicant)
of 931 Benz Rock Rd. (Mailing address), Glide (City),
State of Oregon (Zip Code), do hereby make application for a permit to appropriate the

following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

- The source of the proposed appropriation is Little River + unnamed stream (Name of stream), a tributary of North Umpqua.
- The amount of water which the applicant intends to apply to beneficial use is 0.06 cfs (If water is to be used from more than one source, give quantity from each) unnamed stream domestic 0.01 cfs irrigation 0.05 cfs, any deficiency to be from little river for each
- The use to which the water is to be applied is unnamed stream domestic 0.01 cfs, irrigation 0.05, any deficiency to be from little river for each. (Irrigation, power, mining, manufacturing, domestic supplies, etc.)
- The point of diversion is located 380 ft. N and 410 ft. W from the center corner of Section 34 (Section or subdivision) (2) 1520' N, 585' W From the center corner Section 34 (Little River)

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.055 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from an unnamed stream and Little River. Water to be diverted from unnamed stream when available with any deficiency in the available supply from unnamed stream to be made up by appropriation from Little River provided that the total quantity diverted from both sources shall not exceed 0.055 c.f.s.

The use to which this water is to be applied is domestic use for one family and irrigation, being 0.005 c.f.s. for domestic and 0.05 c.f.s. for irrigation.

If for irrigation, this appropriation shall be limited to 1/80th of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is June 12, 1974

Actual construction work shall begin on or before January 28, 1977 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1977.

Complete application of the water to the proposed use shall be made on or before October 1, 1978..
