SUBJECT TO EXISTING RIGHTS and the following limitations and conditions: The right herein granted is limited to the amount of water which can be applied to beneficial use
and shall not exceed

and Detroit Reservoir constructed under Permit No. R-1625.

If for irrigation, this appropriation shall be limited to1/80th of one cubic foot per
second or its equivalent for each acre irrigated and shall be further limited to a diversion
of not to exceed 22 acre feet per acre for each acre irrigated during the irrigation
season of each year from direct flow and storage from reservoir constructed under
Permit No. 1625, and is subject to the terms and conditions of contract No.
14-06-100-8394 between the Bureau of Reclamation and the applicant, a copy of which
is on file in the records of the Water Resources Department.
