# To Appropriate the Public Waters of the State of Oregon

I, Donald S. Smith (Name of applicant)  
of Trailer sp. 637, trailer park 7 (Mailing address), Vandenberg Air Force Base (City),  
State of California, 93437 (Zip Code), do hereby make application for a permit to appropriate the  
following described public waters of the State of Oregon, SUBJECT TO EXISTING RIGHTS:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is North Umpqua River (Name of stream),  
a tributary of Umpqua River

2. The amount of water which the applicant intends to apply to beneficial use is 0.01  
cubic feet per second (If water is to be used from more than one source, give quantity from each)

3. The use to which the water is to be applied is domestic including not to exceed 1/2  
acre lawn and garden (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located 30' ft. S (N. or S.) and 5 ft. E (E. or W.) from the NW  
corner of Echo Bend Estates Second Addition (Lot 3) (Section or subdivision)

being within the Lot 3 also the SW 1/4 NW 1/4 of Sec. 23 (Give smallest legal subdivision), Tp. 26S (N. or S.),

This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.01 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from North Umpqua River

The use to which this water is to be applied is domestic use for one family, including the irrigation of lawn and garden not to exceed 1/2 acre in area.

If for irrigation, this appropriation shall be limited to of one cubic foot per second or its equivalent for each acre irrigated

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is September 7, 1976

Actual construction work shall begin on or before January 12, 1978 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1978

Complete application of the water to the proposed use shall be made on or before October 1, 1979
