This is to certify that I have examined the foregoing application and do hereby grant the same, SUBJECT TO EXISTING RIGHTS and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 222.53 a.f. stored water only ~~xxxxxx per second~~ measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from Willamette Basin projects constructed under permit No. R-1625 and permit No. R-5363 above the diversion point described herein.

The use to which this water is to be applied is supplemental irrigation.

If for irrigation, this appropriation shall be limited to ~~XXXXXXXXXXXXXXXXXXXX of the water from the~~ a diversion of 2 1/2 acre feet for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land, and shall not exceed the limitation allowed herein, and is subject to the terms and conditions of contract No. 7-07-10-W0058, or a satisfactory replacement, between the Bureau of Reclamation and the applicant, a copy of which is on file in the records of the Water Resources Department,

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is February 15, 1977

Actual construction work shall begin on or before September 14, 1978 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1979.

Complete application of the water to the proposed use shall be made on or before October 1, 1980.
