Briggs D.L.C.No.40 in Section 35, Township 39 south, Range 8 West of the Willamette Meridian; Josephine County, Oregon ;thence South along the east line of said claim, 275 feet, more or less, to the center of Kelly creek; thence southerly said center line to its point of intersection with the Easterly right of way line of Holland Loop Road; thence north 33°01' West along said right of way line 293.00 feet to the center line of an existing road; thence following said center line North 50°24' East 405.45 feet; thence North 65°05' East 379.92 feet to the North line of said D.L.C.; thence East along said North line 1750 feet, more or less; to the point of beginning.

Permit to Appropriate the Public Waters of the State of Oregon

This is to certify that I have examined the foregoing application and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE EXISTING FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.19 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from Tycer Creek when available.... with any deficiency in the available supply from Tycer Creek to be made up by appropriation from Kelly Creek, provided that the total quantity diverted from both sources shall not exceed 0.19 c.f.s.

The use to which this water is to be applied is irrigation

If for irrigation, this appropriation shall be limited to 1/50th of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3½ acre feet per acre for each acre irrigated during the irrigation season of each year.....

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is May 4, 1977

Actual construction work shall begin on or before October 12, 1978 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19...79

Complete application of the water to the proposed use shall be made on or before October 1, 19...80
