### Permit to Appropriate the Public Waters of the State of Oregon

This is to certify that I have examined the foregoing application and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE EXISTING FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 1.27 a.f. stored water only ~~xxxxxx feet per second~~ measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from Fern Ridge Reservoir constructed under permit No. R 1625.

The use to which this water is to be applied is irrigation

RECEIVED

If for irrigation, this appropriation shall be limited to ~~XXXXXXXXXXXXXXXXXXXX of one cubic foot per second~~ ~~xxxx equivalent for each acre irrigated~~ a diversion of 2 1/2 acre feet for each acre irrigated during the irrigation season of each year, and is subject to the terms and conditions of contract No. 7-07-10-W0140, or a satisfactory replacement, between the Bureau of Reclamation and the applicant, a copy of which is on file in the records of the Water Resources Department,

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is July 19, 1976

Actual construction work shall begin on or before November 4, 1978 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1979

Complete application of the water to the proposed use shall be made on or before October 1, 1980
