# To appropriate the Public Waters of the State of Oregon

I, A. Virtue (Name of Applicant)

of Murphy (Postoffice), County of Josephine

State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon subject to existing rights:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Gravelly Slough (Name of stream), tributary of Althouse Creek

2. The amount of water which the applicant intends to apply to beneficial use is 0.71 cubic feet per second.

3. The use to which the water is to be applied is Irrigation. (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located Commencing at the SW corner of Section 31 (Give distance and bearing to section corner) Twp. 39 S R. 7 W; thence east 85 rods; thence north 20 rods.

being within the SW 1/4 of SE 1/4 of Sec. 31, Tp. 39 S (Give smallest legal subdivision) (No. N. or S.)

R. 7 W, W. M., in the county of Josephine (No. E. or W.)

5. The ditch to be 180 rods (Main ditch, canal or pipe line)

1/2 miles in length, terminating in the SE 1/4 of NW 1/4 of Sec. 6, Tp. 40 S (Smallest legal subdivision) (No. N. or S.)

R. 7 W W. M., the proposed location being shown throughout on the accompanying map. (No. E. or W.)

## DESCRIPTION OF WORKS

### DIVERSION WORKS—

STATE OF OREGON, County of Marion, ss.

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions: If for irrigation, this appropriation shall be limited to one-eightieth of one cubic foot per second, or its equivalent, for each acre irrigated, and shall be subject to such reasonable rotation system as may be ordered by the proper State officer.

The right to the use of water herein granted is limited to irrigation purposes.

The amount of water appropriated shall be limited to the amount which can be applied to beneficial use and not to exceed 0.56 cubic feet per second, or its equivalent in case of rotation. The priority date of this permit is October 15, 1919.

Actual construction work shall begin on or before October 30, 1920 and shall thereafter be prosecuted with reasonable diligence and be completed on or before June 1, 1921.

Complete application of the water to the proposed use shall be made on or before October 1, 1922
