4. The amount of water which the applicant intends to apply to beneficial use is 0.01 c.f.s. from cubic feet per second POD #2 with any deficiency to be supplemented by appropriation from POD #1 (If water is to be used from more than one source, give quantity from each)

5. The use to which the water is to be applied is 2 Domestic uses plus up to 1/2 acre-lawn & garden irrigation

DESCRIPTION OF WORKS

Include dimensions and type of construction of diversion dam and headgate, length and dimensions of supply ditch or pipeline, size and type of pump and motor, type of irrigation system to adequately describe the proposed distribution system.

POD #2 & POD #1 are both in use at the present.

POD #2 consists of 1-500 gal metal tank served by 50' of 1" plastic pipe imbedded in spring source. Outfall is by a combination of 1 1/4" & 1" plastic pipe to existing house and garden spot.

POD #1 consists of 1200 gal plastic tank supplied by 50' of 1 1/4" plastic pipe. Outfall is by 1 1/2" & 1" plastic pipe to existing house and garden spot. Both systems are independent but are cross connected at house with a series of valves.

Both systems are gravity. No pumps are in use.

Permit to Appropriate the Public Waters of the State of Oregon

This is to certify that I have examined the foregoing application and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE EXISTING FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.01 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from unnamed stream #1, with any deficiency in the available supply from unnamed stream #1 to be made up by diversion from unnamed stream #2.

The use to which this water is to be applied is.....domestic use for two families including the irrigation of lawn and garden not to exceed $\frac{1}{2}$ acre for each family.

If for irrigation, this appropriation shall be limited to of one cubic foot per second or its equivalent for each acre irrigated.....

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is March 6, 1978

Actual construction work shall begin on or before..... May 3, 1979 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19...80.....

Complete application of the water to the proposed use shall be made on or before October 1, 19...81.....
