APPLICATION FOR A PERMIT

To appropriate the Public Waters of the State of Oregon

I, J A Adams (Name of Applicant) of Freewater Oregon (Postoffice), County of Umatilla State of Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon subject to existing rights:

If the applicant is a corporation, give date and place of incorporation.

1. The source of the proposed appropriation is Little Walla Walla River thru the Pleasant View Ditch (Name of stream), tributary of (L.W.W. is a trib. of Columbia)

2. The amount of water which the applicant intends to apply to beneficial use is 0.15 cubic feet per second.

3. The use to which the water is to be applied is Irrigation (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located (Pleasant View Ditch S 39° 0' W from Sec. corner of Section 35 - 36 Tp. 6 N R 35 E and Sec. 1 - 2 of Tp 5 N R 35 E.) Diversion from Pleasant View Ditch, due South 1980 ft. from 1/4 Sec. corner between Sec. 34 and 27 Tp 6 N R 35 E.W.M.

being within the SE 1/4 of NW 1/4 of Sec. 34, Tp. 6 N R. 35 E, W. M., in the county of Umatilla (No. E. or W.) (Give smallest legal subdivision) (No. N. or S.)

5. The Pleasant View Ditch (Main ditch, canal or pipe line) to be is about 1 1/2 miles in length, terminating in the to the point of diversion from same of Sec. (Smallest legal subdivision) (No. N. or S.) R. W. M., the proposed location being shown throughout on the accompanying map. (No. E. or W.)

6. The name of the ditch, canal or other works is Adams' Ditch out of Pleasant View Ditch

DESCRIPTION OF WORKS

DIVERSION WORKS— As the Pleasant View Ditch divides at this point a small 3-way concrete divide will be put in at this point.

STATE OF OREGON, } ss. County of Marion,

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions: If for irrigation, this appropriation shall be limited to one-eightieth of one cubic foot per second, or its equivalent, for each acre irrigated, and shall be subject to such reasonable rotation system as may be ordered by the proper State officer.

The right to the use of water herein granted is limited to irrigation purposes.

The amount of water appropriated shall be limited to the amount which can be applied to beneficial use and not to exceed 0.13 cubic feet per second, or its equivalent in case of

rotation. The priority date of this permit is December 15, 1919

Actual construction work shall begin on or before December 27, 1920 and shall

thereafter be prosecuted with reasonable diligence and be completed on or before June 1, 1921

Complete application of the water to the proposed use shall be made on or before October 1, 1922
