THE SYSTEM IS OF THE GRAVITY TYPE. A SMALL CATCH BASIN IN THE COURSE OF WATER FLOW WAS FORMED, 2 FT. BY 2 FT. AND 10 INCHES DEEP, FROM WHICH A ONE INCH PIPE EXTENDS ALLOWING THE WATER TO FLOW INTO A WOODEN TANK 54 INCHES SQUARE AND 6 FT. HIGH. THE CAPACITY IS ABOUT 300 GAL. FROM THIS TANKS A THREE INCH PIPE GOES DOWN TO MY PROPERTY APPROX 250 FT. AWAY WHICH ENDS THERE AT A FAUCET. WATER WILL COME INTO THE HOUSE FROM A ONE INCH PLASTIC PIPE AS SHOWN THE MAP.

Permit to Appropriate the Public Waters of the State of Oregon

This is to certify that I have examined the foregoing application and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE EXISTING FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed0.01..... cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from ..an..unnamed..spring.....

The use to which this water is to be applied is.....domestic use for one family including..... irrigation of not to exceed $\frac{1}{2}$ acre lawn and non-commercial garden.....

If for irrigation, this appropriation shall be limited to of one cubic foot per second or its equivalent for each acre irrigated.....


