 2" pipe from spring box - Gravity use to pressurize the system  
 3/4" pipe from the main to each house.....

Springs 2 & 3 to be developed and used together in a gravity system to irrigate the acres shown. A pump may have to be used to boost pressure. The Mainline from the springs is proposed at this time to be 3". Land is to be sprinkler irrigated with lateral lines as needed.

**Permit to Appropriate the Public Waters of the State of Oregon**

This is to certify that I have examined the foregoing application and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE EXISTING FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed .....0.14..... cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from ..three springs.....

The use to which this water is to be applied is....domestic use for three families including....irrigation of a lawn or non-commercial garden and irrigation being 0.02 c.f.s...for domestic use and lawn or garden irrigation from spring No. 1, 0.06 c.f.s. from spring No. 2 and 0.06 c.f.s...from spring No. 3 for irrigation.....

If for irrigation, this appropriation shall be limited to .....1/40th..... of one cubic foot per second or its equivalent for each acre irrigated....and shall be further limited to a diversion of not.....to exceed 5.0 acre feet per acre for each acre irrigated during the irrigation.....season of each year.....

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is .....October 22, 1979.....

Actual construction work shall begin on or before.....February 25, 1981..... and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19.81.....
