Permit to Appropriate the Public Waters of the State of Oregon

This is to certify that I have examined the foregoing application and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE EXISTING FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed0.26..... cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from Day Creek, Oxford Creek, two unnamed streams and Oxford Reservoir to be constructed under application No. R-58853, permit No. R-8106.....

The use to which this water is to be applied is irrigation, domestic use for one family, and recreation being 0.11 cfs from Day Creek for irrigation, 0.12 cfs from Oxford Creek for irrigation, 0.01 cfs from Oxford Creek and Oxford Reservoir for recreation, 0.005 cfs for irrigation and 0.005 cfs for domestic use for one family from the unnamed stream No. 1 with any deficiency in the available supply from unnamed stream No. 1 to be made up from unnamed stream No. 2 provided that the total quantity **


