x A 50 H.P. Electric Pump with 6" Section Line and 8" Discharge. Pump is located at waters edge on Custer River approx 5 miles north of Pacific Ocean. 30' x 6" Section Line draw water directly from River. Balance of system consists of 1/100 of 8" main line reducing to 800' of 6" 3" laterals are used to feed the 7 Big Bear sprinklers.

No construction in River is needed for pump or section line.

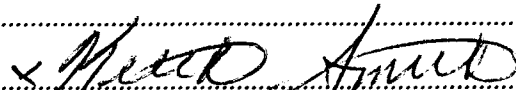

Permit to Appropriate the Public Waters of the State of Oregon

This is to certify that I have examined the foregoing application and do hereby grant the same **SUBJECT TO EXISTING RIGHTS INCLUDING THE EXISTING FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD** and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 1.97 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from Chetco River

The use to which this water is to be applied is irrigation

If for irrigation, this appropriation shall be limited to 1/80th of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is March 17, 1980

Actual construction work shall begin on or before May 21, 1981 and shall

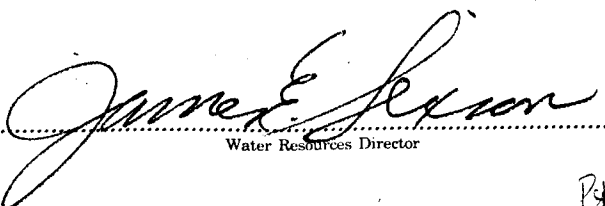
thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1982
