6. DESCRIPTION OF WORKS

Include dimensions and type of construction of diversion dam and headgate, length and dimensions of supply ditch or pipeline, size and type of pump and motor, type of irrigation system to adequately describe the proposed distribution system.

The reservoir from which water is being appropriated under this application is to be filled by a Parma high volume - low pressure pump from the Rogue River Irrigation District's "401 Lateral". This lateral is located approximately 250 feet south of the reservoir adjacent to our property. The water will be transmitted to the reservoir in a 12 inch PVC pipe.

The water will be used for Supplemental Temperature Control on 70.5 acres of pear and apple orchard. The water will be pumped from the pond by four 50 horsepower pumps and distributed into the orchard by buried PVC pipe. The water will be applied in the orchard through 21' steel riser pipes and impact sprinklers

Permit to Appropriate the Public Waters of the State of Oregon

This is to certify that I have examined the foregoing application and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE EXISTING FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 13.0 acre feet stored water only measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from Indian Springs Reservoir to be constructed under application No. R-59701, permit No. R-8129

The use to which this water is to be applied is temperature control

If for irrigation, this appropriation shall be limited to of one cubic foot per second or its equivalent for each acre irrigated

The permittee shall record and submit annually to the Water Resources Department all pertinent data pertaining to use of water for temperature control on forms furnished.

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is January 11, 1980

Actual construction work shall begin on or before May 21, 1981 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1982

Complete application of the water to the proposed use shall be made on or before October 1, 1983
