Permit to appropriate the Public Waters of the State of Oregon

This is to certify that I have examined the foregoing application and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE EXISTING FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 30 acre-feet stored water only cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from a reservoir constructed under Application No. R-23694, Permit No. R-1030

The use to which this water is to be applied is irrigation

If for irrigation, this appropriation shall be limited to of one cubic foot per second or its equivalent for each acre irrigated and shall be limited to a diversion of not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided that no diversion of water is to be made, except from waters legally stored, and that the use of water is subject to the terms of the sales contract between Charles C. & Velva L. Jackson and Leslie C. & Floris C. Gold dated February 9, 1977 and the easement grant as set forth in the instrument recorded in Book 977, Page 880, Washington County Deed Records wherein permittee is allowed an undivided one-half interest in the reservoir and is allowed to share equally in the utilization of water from the reservoir.

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is May 18, 1979

Actual construction work shall begin on or before May 21, 1981 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1982

Complete application of the water to the proposed use shall be made on or before October 1, 1983
