Remarks: When we purchased this property in April, 1978 this pumping system was in and had been in use for a number of years. We were told that we had a water right to pump from the river to maintain the pond and to irrigate - that this right dated back to the early 1950's.

A recent investigation into the matter, however, revealed that this right allows for irrigating only a small portion of our property farthest from the river. Hence this application for the right to maintain that which is already there.

### Permit to appropriate the Public Waters of the State of Oregon

*This is to certify that I have examined the foregoing application and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE EXISTING FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:*

*The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.05 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from Applegate River*

*The use to which this water is to be applied is irrigation and fish culture; being 0.03 cfs for irrigation and 0.02 cfs for fish culture.*

*If for irrigation, this appropriation shall be limited to 1/80th of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year.*


*and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.*

*The priority date of this permit is June 6, 1980*

*Actual construction work shall begin on or before October 14, 1981 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1982*

*Complete application of the water to the proposed use shall be made on or before October 1, 1983*
