

Remarks: Due to personal expenses (divorce) I was forced to allow this permit to expire in 1978. I am now in a position to proceed with the permit according to the original application and map filed in February 1972, and am requesting reinstatement of the permit then issued. I have a permit from the D.E.Q. for the septic system necessary to complete application of Spring #2.

This permit, when issued, is for the beneficial use of water. By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan. It is possible that the land use you propose may not be allowed if it is not in keeping with the goals and the acknowledged plan. Permit to appropriate the Public Waters of the State of Oregon

This is to certify that I have examined the foregoing application and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE EXISTING FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.02 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from two unnamed springs

The use to which this water is to be applied is domestic use for two families including irrigation of not to exceed 1/2 acre lawn and non-commercial garden each, being 0.01 cfs from each spring for domestic use for one family each.

If for irrigation, this appropriation shall be limited to of one cubic foot per second or its equivalent for each acre irrigated

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is December 5, 1980

Actual construction work shall begin on or before March 3, 1982 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1982

Complete application of the water to the proposed use shall be made on or before October 1, 1983
