Remarks: Legal Description - Beginning at the south quarter corner of Section 33 in Township 39 South, Range 3 West of the Willamette Meridian in Jackson County, Ore; thence North, along the north-south center line of said Section 1111.19 feet; thence West 425.30 ft, more or less, to the centerline of the Applegate River; thence Southwesterly, along said centerline, ~~of the Applegate River~~ to the west line of the Southeast Quarter of the Southwest Quarter of said Section 33; thence South, along said west line to the south line of said Section; thence East, along said south line to the point of beginning.

Permit to Appropriate the Public Waters of the State of Oregon

This is to certify that I have examined the foregoing application and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE EXISTING FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.11 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from ...Applegate River.....

The use to which this water is to be applied is..... irrigation.....

If for irrigation, this appropriation shall be limited to 1/80th of one cubic foot per second or its equivalent for each acre irrigated..... and shall be further limited to a diversion of not to exceed 4½ acre-feet per acre for each acre irrigated during the irrigation season of each year.....

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.


