An 18" RCP is placed on end over the spring. The RCP is capped and has a 2" PVC pipe feeding into an 1850 gallon storage tank. The outlet of the tank is provided with an overflow pipe. The overflow goes into Freeman Creek. The water is conveyed by a 2" PVC line to the point of usage.

This is to certify that I have examined the foregoing application and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE EXISTING FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:
