6. DESCRIPTION OF WORKS

Include dimensions and type of construction of diversion dam and headgate, length and dimensions of supply ditch or pipeline, size and type of pump and motor, type of irrigation system to adequately describe the proposed distribution system.

POD #1-Pipe thru the ditch bank of the Dayville Ditch using a gravity pressurized system to irrigate the 0.6 acre shown on map. Water is wastewater collected in the Dayville ditch from land irrigated to the SW of the ditch by the Cummings Ditch (South Fork John Day R. Water) Our Property Line roughly follows the Dayville Ditch with a few exceptions as shown. If gravity pressure system doesn't do the job a pump may be used to increase pressure.

POD 's 2 thru 4 will be used as pumping points from the South Fork of the John Day River to supplement supply of wastewater irrigated land. Also primary irrigation of 1.2 acres as shown on map. Pump will be a portable unit movable between points. Size of pump not yet determined but will be adequate to irrigate land developed by sprinklers.

### Permit to appropriate the Public Waters of the State of Oregon

This is to certify that I have examined the foregoing application and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE EXISTING FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.045 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from waste water and South Fork John Day River

The use to which this water is to be applied is irrigation and supplemental irrigation, being 0.015 cfs from waste water and 0.03 cfs from South Fork John Day River for irrigation and 0.015 cfs from South Fork John Day River for supplemental irrigation.

If for irrigation, this appropriation shall be limited to 1/40th of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4 acre-feet per acre for each acre irrigated during the irrigation season of each year; provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein; and shall also be limited to the waste water available at the proposed point of diversion, and shall not carry with it the right to compell the continuance of waste water;

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is April 24, 1981

Actual construction work shall begin on or before May 29, 1982 and shall

thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1983

Complete application of the water to the proposed use shall be made on or before October 1, 1984
