5. The use to which the water is to be applied is supplemental water for  
irrigation + primary

6- DESCRIPTION OF WORKS

Include dimensions and type of construction of diversion dam and headgate, length and dimensions of supply ditch or pipeline, size and type of pump and motor, type of irrigation system to adequately describe the proposed distribution system.

A 20hp electric motor and a 3" pump is in position and usable. An eight foot high flash board dam maintains water level and storage. The dam is 21' in width and height can be adjusted by adding boards in the dam.

The pipes that carry the water to the field are 5" main line while the laterals are 3". Sprinklers at 40' intervals provide the distribution of the water on the field-

Permit to Appropriate the Public Waters of the State of Oregon

This is to certify that I have examined the foregoing application and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE EXISTING FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.25 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from Soap Creek

The use to which this water is to be applied is primary and supplemental irrigation, being 0.09 cfs for primary and 0.16 cfs for supplemental.

If for irrigation, this appropriation shall be limited to 1/80th of one cubic foot per second or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 1/2 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein,

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is March 25, 1981 for 0.16 cfs, May 21, 1981 for 0.09 cfs

Actual construction work shall begin on or before June 15, 1982 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1983

Complete application of the water to the proposed use shall be made on or before October 1, 1984
