APPLICATION FOR A PERMIT

To appropriate the Public Waters of the State of Oregon

I, Amy Rinehart of Summerville, Oregon, do hereby make application for a permit to appropriate the following described public waters of the State of Oregon subject to existing rights:

If the applicant is a corporation, give date and place of incorporation

1. The source of the proposed appropriation is Outhouse Creek (Name of stream)

tributary of Grande Ronde River

2. The amount of water which the applicant intends to apply to beneficial use is 0.35 cubic feet per second.

3. The use to which the water is to be applied is Irrigation and Stock water (Irrigation, power, mining, manufacturing, domestic supplies, etc.)

4. The point of diversion is located 150 feet West of the SE corner of the SW 1/4 of Section 10 Tp 1 S R 39 E.W.M. (Give distance and bearing to section corner)

being within the SE 1/4 SW 1/4 of Sec. 10, Tp. 1 S, R. 39 E, W. M., in the county of Union (No. N. or S.)

5. The ditch to be one-half miles in length, terminating in the SW 1/4 SW 1/4 of Sec. 10, Tp. 1 South, R. 39 East (Smallest legal subdivision) (No. N. or S.)

6. The name of the ditch, canal or other works is No ditch except laterals. No name

DESCRIPTION OF WORKS

DIVERSION WORKS—

7. (a) Height of dam one feet, length on top six feet, length at bottom six feet; material to be used and character of construction Brush and earth (Loose rock, concrete, masonry, rock and brush, timber crib, etc., wasteway over or around dam)

(b) Description of headgate None at present, but if water master desires one to be installed, will place same as directed. (Timber, concrete, etc., number and size of openings)

This is to certify that I have examined the foregoing application and do hereby grant the same, subject to the following limitations and conditions: If for irrigation, this appropriation shall be limited to one-eightieth of one cubic foot per second, or its equivalent, for each acre irrigated, and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The right to the use of water herein granted is limited to irrigation and stock purposes.

The amount of water appropriated shall be limited to the amount which can be applied to beneficial use and not to exceed 0.35 cubic feet per second, or its equivalent in case of rotation. The priority date of this permit is April 16, 1920

Actual construction work shall begin on or before May 18, 1921 and shall thereafter be prosecuted with reasonable diligence and be completed on or before June 1, 1922

Complete application of the water to the proposed use shall be made on or before October 1, 1923
