#### DESCRIPTION OF WORKS

Include dimensions and type of construction of diversion dam and headgate, length and dimensions of supply ditch or pipeline, size and type of pump and motor, type of irrigation system to adequately describe the proposed distribution system.

Steel Headgate with 24" outlet Approximately 2500 feet of existing ditch then water runs down Painters Gulch to Little Pine Creek.

Water is then flumed over Little Pine Creek to an existing ditch 4250 feet in length to mining area.

Ditch is 2' on bottom 3' deep and 5' wide across the top.

Using two 400 G.P.M. pumps and 8 inch pipeline to recirculate water.

Water is pumped to trommel which is fed by a Front End Loader.

Water then washes the material out the end of trommel and then it drops into 30' of sluise.

Have seven settling ponds in mining area.

### Permit to Appropriate the Public Waters of the State of Oregon

*This is to certify that I have examined the foregoing application and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE EXISTING FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:*

*The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 2.0 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from Dog Creek and Little Pine Creek, being 1.0 cfs from each.*

*The use to which this water is to be applied is mining*

*If for irrigation, this appropriation shall be limited to ----- of one cubic foot per second or its equivalent for each acre irrigated.....*

*This permit is issued subject to the maintenance and use of adequate treatment facilities to remove the sediment before returning the water to the stream system.....*

*and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.*

*The priority date of this permit is March 16, 1981*

*Actual construction work shall begin on or before September 10, 1982 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1983*

*Complete application of the water to the proposed use shall be made on or before October 1, 1984*
