Remarks: The division of full duty and $\frac{1}{2}$ duty is made as a result of a $\frac{1}{2}$ duty right already existing on a portion of the land to be irrigated (see permit #4378, certificate #30856); full duty is applied to balance of land with no water right, along with another $\frac{1}{2}$ duty on that which already has a $\frac{1}{2}$ duty right in order to bring the total to full duty for the whole parcel of land in question. City of Baker reservoir is tied to above; Kolb Reservoir is supplemental to all lands.

This permit, when issued, is for the beneficial use of water. By law, the land use associated with this water use must be in compliance with statewide land-use goals and any local acknowledged land-use plan. It is possible that the land use you propose may not be allowed if it is not in keeping with the goals and the acknowledged plan. Your city or county planning agency can advise you about the land-use plan in your area.

Permit to Appropriate the Public Waters of the State of Oregon

This is to certify that I have examined the foregoing application and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE EXISTING FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0,548..... cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from overflow from City of Baker Reservoir and Kolb Reservoir to be constructed under Application R-61086, Permit R- 8297.....

The use to which this water is to be applied is..... irrigation and supplemental irrigation.....

If for irrigation, this appropriation shall be limited to 1/40th of one cubic foot per second or its equivalent for each acre irrigated..... from direct flow and shall be further limited to a diversion of not to exceed 3½ acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage from reservoir constructed under Permit R- 8297., provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein,

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is December 22, 1980.....

Actual construction work shall begin on or before..... September 10, 1982..... and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1983.....

Complete application of the water to the proposed use shall be made on or before October 1, 1984.....
