I plan on diverting a small amount of creek into shallow 4'x6' pool then another shallow 4'x6' pool then into 36"x 8' concrete tile installed on end with flow of stream then diverted back into creek. Either submersible or jet-type pump thru 1 1/4" plastic pipe to pressure tank near house.

All dams and spills will be dirt and stone. All excavation will be by hand or hand-operated trench machine.

If for domestic use state number of families to be supplied ..... 2 households.....

## Permit to Appropriate the Public Waters of the State of Oregon

This is to certify that I have examined the foregoing application and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE EXISTING FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed ..... 0.01 ..... cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from ..... an unnamed stream .....

The use to which this water is to be applied is ..... domestic use for two families .....
