1) The pipeline will consist of 275 feet of 1" PVC pipe. Irrigation will be done by means of sprinklers on this line. The entire distribution system will contained within the boundaries of Lot 11 Block 3 of the Mill Creek Glen Second addition.

2) A 1/2 hp stationary self-priming centrifugal pump will be employed to obtain water from the source specified. The intake pipe to the pump will consist of 1 1/4 " PVC pipe.

Gilcher have already obtained water rights from the same source that I will use. Their permit number is 39733. As my property adjoins theirs, I am petitioning for secondary rights from the common source.

Permit to appropriate the Public Waters of the State of Oregon

This is to certify that I have examined the foregoing application and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE EXISTING FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.01 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from an unnamed creek

The use to which this water is to be applied is irrigation

If for irrigation, this appropriation shall be limited to 0.0375 ~~of one~~ cubic foot per second or its equivalent for each acre irrigated

and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.

The priority date of this permit is September 4, 1980

Actual construction work shall begin on or before October 7, 1982 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 19. 83

Complete application of the water to the proposed use shall be made on or before October 1, 19. 84
