2. The point of diversion is to be located #2 112 ft. S (N. or S.) and 330 ft. E (E. or W.)

from the SW 1/4 corner of NW 1/4 SW 1/4 (Public Land Survey Corner)

4. The amount of water which the applicant intends to apply to beneficial use is 0.01 C.F.S. from cubic feet per second. from spring with any deficiency in supply to be supplemented by Wind stream

5. The use to which the water is to be applied is domestic use to include up to 1/2 acre of lawn + garden irrigation

6. DESCRIPTION OF WORKS

Include dimensions and type of construction of diversion dam and headgate, length and dimensions of supply ditch or pipeline, size and type of pump and motor, type of irrigation system to adequately describe the proposed distribution system.

POD #1 <sup>Spring box</sup> A cement spring box 30" x 42" x approx 8" in high catches the water as it leaves the ground and a 1" filtered pipe carries the water from the box 380 feet to a 15,000 gal storage tank. A 3" pipe carries the water to the pump house (pump is a 2 H.P. Sta-Rite) with 2 pressure tanks + 1 chlorinator tank. Three inch pipe carries water 240' where pipe is reduced to 1 in at edge of property to the mobile home.

POD #2 25' below spring box a diversion dam of rocks and clay is formed from which a 1" pipe carries water 355' to storage tank (15,000 gal.) and a 3" pipe to pump with 2 H.P. motor and pressure tanks. 3" pipe carries water to property (355') 2" pipe which is used for mobile home.

### Permit to Appropriate the Public Waters of the State of Oregon

*This is to certify that I have examined the foregoing application and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE EXISTING FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:*

*The right herein granted is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.01 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users, from a spring when available with any deficiency in the available supply at the spring to be made up by appropriation of water from an unnamed stream*

*The use to which this water is to be applied is domestic use for one family including irrigation of a lawn or noncommercial garden not to exceed 1/2 acre in area*

*If for irrigation, this appropriation shall be limited to of one cubic foot per second or its equivalent for each acre irrigated*


*and shall be subject to such reasonable rotation system as may be ordered by the proper state officer.*

*The priority date of this permit is October 2, 1980*

*Actual construction work shall begin on or before October 29, 1982 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1983*

*Complete application of the water to the proposed use shall be made on or before October 1, 1984*
