PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined Application 60309 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to William R. Lewis and Myron Miles of North Powder, Oregon 97867, Phone 898-2176, for the use of the waters of North Powder River, a tributary of Powder River, for the purpose of irrigation and supplemental irrigation; that the priority of the right dates from November 2, 1981 and is limited to the amount of water which can be applied to beneficial use and shall not exceed 8.71 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users.

The POINTS OF DIVERSION are to be located: Diversion 1 - 690 feet north and 680 feet west from the northeast corner of Section 22; Diversion 2 - 1,590 feet north and 1,210 feet west from the southeast corner of Section 22, both being within the NE 1/4SE 1/4 of Section 22, Township 6 South, Range 39 East, WM, in the counties of Baker and Union.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second or its equivalent for each acre irrigated from the first day of March to the first day of July and one-eightieth of one cubic foot per second or its equivalent for each acre irrigated from the first day of July to the first day of October of each year, provided further that the right allowed herein shall be further limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

A description of the place of use under the permit, and to which such right is appurtenant, is as follows:

Complete application of the water to the proposed use shall be made on or before October 1, 1984.
