## PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 61123 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Mt. Vernon Irrigation and Power Company by Pierre Jones of Route 1, Box 10, Mt. Vernon, Oregon 97865, phone 932-4488, for the use of the waters of John Day River, a tributary of Columbia River, for the PURPOSE of supplemental irrigation; that the PRIORITY OF THE RIGHT dates from January 8, 1981, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 3.27 cubic foot per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users.

The POINT OF DIVERSION is to be LOCATED: 520 feet South and 2,030 feet East from the Northwest Corner of Section 25, being within the NE 1/4 NW 1/4 of Section 25, Township 13 South, Range 30 East, WM, in the County of Grant.

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre irrigated, and shall be further limited, together with the amount secured under any other right existing for the same lands, to 5.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before February 23, 1983 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1983.

Complete application of the water to the proposed use shall be made on or before October 1, 1984.
