PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 61768 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Vern Retzlaff of 15391 Airlie Road, Monmouth, Oregon 97361, phone 838-1268, for the use of the waters of Little Luckiamute River, for the PURPOSE of irrigation and supplemental irrigation; that the PRIORITY OF THE RIGHT dates from December 4, 1981, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.35 cubic foot per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users.

The POINTS OF DIVERSION are to be LOCATED: Diversion 1 - 1,800 feet North and 480 feet West, Diversion 2 - 1,860 feet North and 1,000 feet West, both from the Southeast Corner of Section 7, being within the NE 1/4 SE 1/4 of Section 7, Township 9 South, Range 5 West, WM, in the County of Polk.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, from direct flow and shall be further limited to a diversion of not to exceed two and one-half acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein for the lands described as supplemental shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before March 2, 1983 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1983.

Complete application of the water to the proposed use shall be made on or before October 1, 1984.
