PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 60716 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Donald Simms of Route 2, Box 435, Lakeview, Oregon 97630, phone 947-2774, for the use of the waters of Clover Creek and four drainages, being 2.31 cubic feet per second from Clover Creek, 0.25 cfs from Drainage 1, 0.25 cfs from Drainage 2, 0.25 cfs from Drainage 3, and 0.30 cfs from Drainage 4, tributaries of Crooked Creek and Abert Lake, for the PURPOSE of irrigation. The use allowed herein may be made anytime between October 1 and March 31, that water can be put to beneficial use by irrigation, either for immediate crop growth or for forecast requirements to raise the soil moisture to field capacity in the soil profile to be utilized by plant growth in the subsequent growing season; that the PRIORITY OF THE RIGHT dates from December 4, 1981, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 3.36 cfs measured at the points of diversion from the streams, or its equivalent in case of rotation with other water users.

The POINTS OF DIVERSION are to be LOCATED: Diversion 1 (Drainage 1) - 900 feet North and 1,950 feet East from the W 1/4 of Section 21, being within the SE 1/4 NW 1/4 of Section 21; Diversion 2 (Drainage 2) - 1,450 feet North and 1,310 feet East from the Southwest Corner of Section 21, being within the NW 1/4 SW 1/4 of Section 21; Diversion 3 (Drainage 3) - 1,050 feet South and 1,050 feet East from the Northwest Corner of Section 28, being within the NW 1/4 NW 1/4 of Section 28; Diversion 4 (Drainage 4) - 600 feet North and 100 feet West from the Southeast Corner of Section 29, being within the SE 1/4 SE 1/4 of Section 29; and Diversion 5 (Clover Creek) - 650 feet South and 1,600 feet West from the Northeast Corner of Section 32, being within the NW 1/4 NE 1/4 of Section 32, all within Township 36 South, Range 21 East, WM, in the County of Lake.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, from direct flow and shall be further limited to a diversion of not to exceed one and one-half acre-feet per acre for each acre irrigated during the period from October 1 to March 31, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before March 17, 1983 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1983.

Complete application of the water to the proposed use shall be made on or before October 1, 1984.
