PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 51780 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to City of Wilsonville, of PO Box 220, Wilsonville, Oregon 97070, phone 682-1011, for the use of the waters of Willamette River, a tributary of Columbia River, for the PURPOSE of municipal use; that the PRIORITY OF THE RIGHT dates from March 27, 1974, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 30.0 cubic feet per second measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users.

The POINT OF DIVERSION is to be LOCATED: 3,500 feet South and 200 feet West from the Southwest Corner of Section 14, being within the NE 1/4 SE 1/4 of Section 22, Township 3 South, Range 1 West, WM, in the County of Clackamas.
