PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 59887 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Robert W. Metlen of PO Box 553, Ontario, Oregon 97914, phone 889-6862, for the use of the waters of an unnamed creek, for the PURPOSE of irrigation, domestic use for one family and stock use, being 0.11 cubic foot of water per second for irrigation, 0.005 cfs for domestic use for one family and 0.01 cfs, not to exceed 600 gallons per day for stock use; that the PRIORITY OF THE RIGHT dates from June 26, 1981, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 0.125 cfs measured at the point of diversion from the stream, or its equivalent in case of rotation with other water users.

The POINTS OF DIVERSION are to be LOCATED: Diversion 1 - 740 feet South and 510 feet East from the Northwest Corner of the SE 1/4 NW 1/4 of Section 9 and Diversion 2 - 100 feet South and 510 feet East from the Northwest Corner of the SE 1/4 NW 1/4 of Section 9, being within the SE 1/4 NW 1/4 of Section 9, Township 18 South, Range 46 East, WM, in the County of Malheur.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

Township 18 South Range 46 East, WM Section 9 SE 1/4 NW 1/4 4.5 acres irrigation, domestic use for one family and stock use NW 1/4 SE 1/4 stock use

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-fortieth of one cubic foot per second per acre, from direct flow and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year, and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

Actual construction work shall begin on or before Merch 30, 1983 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1983. Extended to Oct. 1, 1984

Complete application of the water to the proposed use shall be made on or before October 1, 1984.
