PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 61422 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to City of Redmond, of 455 South 7th Street, Redmond, Oregon 97756, phone 548-2148, for the use of the waters of Sewage Effluent Storage Reservoir to be constructed under Application R-60935, Permit R-8336, for the PURPOSE of supplemental irrigation; that the PRIORITY OF THE RIGHT dates from March 20, 1981, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 286.0 acre-feet stored water only.

The POINT OF DIVERSION is to be LOCATED: 860.85 feet North and 693.61 feet West from the S 1/4 Corner of Section 19, being within the SE 1/4 SW 1/4 of Section 19, Township 14 South, Range 13 East, WM, in the County of Deschutes.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to a diversion of 4.0 acre-feet for each acre irrigated during the irrigation season of each year from storage from reservoir to be constructed under Permit R-8336, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

Actual construction work shall begin on or before March 30, 1983 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1983.

Complete application of the water to the proposed use shall be made on or before October 1, 1984.
