PERMIT TO APPROPRIATE THE PUBLIC WATERS

This is to certify that I have examined APPLICATION 62144 and do hereby grant the same SUBJECT TO EXISTING RIGHTS INCLUDING THE APPROPRIATE MINIMUM FLOW POLICIES ESTABLISHED BY THE WATER POLICY REVIEW BOARD and the following limitations and conditions:

This permit is issued to Martin and Linda Heltkamp and Richard and Rose Leever of 3072 Griffin Creek Road, Medford, Oregon 97501, phone 773-6893, for the use of the waters of Applegate Lake Reservoir constructed under Permit R-7810, a tributary of Applegate River, for the PURPOSE of supplemental irrigation; that the PRIORITY OF THE RIGHT dates from August 6, 1981, and is limited to the amount of water which can be applied to beneficial use and shall not exceed 4.0 acre-feet stored water only.

The POINT OF DIVERSION is to be LOCATED: 50 feet North and 1,190 feet East from the Southwest Corner of Section 19, being within the SW 1/4 SW 1/4 of Section 19, Township 40 South, Range 3 West, WM, in the County of Jackson.

The POINT OF DIVERSION for Applegate Dam is within the S 1/2 SE 1/4 of Section 25, Township 40 South, Range 4 West, WM.

A description of the PLACE OF USE under the permit, and to which such right is appurtenant, is as follows:

The AMOUNT OF WATER used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to four and one-half acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and is subject to the terms and conditions of Contract 1-07-10-W0328 between the Bureau of Reclamation and the applicant, or a satisfactory replacement, a copy of which is on file in the records of the Water Resources Director.

Actual construction work shall begin on or before March 30, 1983 and shall thereafter be prosecuted with reasonable diligence and be completed on or before October 1, 1983.

Complete application of the water to the proposed use shall be made on or before October 1, 1984.
